1. Introduction

The purpose of this circular is to provide you with information regarding some of the resolutions to be proposed at the AGM to be held as a hybrid meeting at 1st Floor, Harbour Grand Kowloon, 20 Tak Fung Street, Hung Hom, Kowloon, Hong Kong and online on Wednesday, 21st May, 2025 at 2:15 p.m. Hong Kong time (7:15 a.m. London time) (or (i) as the Directors may, in their absolute discretion in accordance with the Company's Bye-laws, change the place of the AGM at the same time and on the same date by way of an announcement without the need to give a new notice of the AGM or (ii) in the event that a black rainstorm warning signal, a tropical cyclone warning signal no. 8 or above, or "extreme conditions" as announced by the Hong Kong Government is/are in force in Hong Kong at 9:00 a.m. Hong Kong time (2:00 a.m. London time) on that day, at the same time and place on Monday,

26th May, 2025), including (i) the ordinary resolutions proposing the election of Directors who are due to retire at the AGM; and (ii) the ordinary resolutions granting the Board the general mandates to issue and buy back shares of HK\$1.00 each in the capital of the Company ("Shares"); and to give you notice of the AGM at which the ordinary resolutions as set out in the notice of the AGM dated 16th April, 2025 ("Notice of AGM") will be proposed.

2. Proposed Election of Directors

In accordance with Bye-law 87(1) of the Company's Bye-laws and following the review of the Board's composition by the nomination committee of the Company ("Nomination Committee"), Mr. Kam Hing Lam, Mr. Frank John Sixt, Mr. Chan Loi Shun, Mrs. Kwok Eva Lee and Mrs. Lee Pui Ling, Angelina ("Retiring Directors") have been proposed to the Board for recommendation to the Shareholders for re-election at the AGM. Mrs. Kwok Eva Lee, being the chairperson of the Nomination Committee, abstained from voting on the resolutions of the Nomination Committee for considering her own nomination.

Biographical information of all of the Retiring Directors (including but not limited to their respective perspectives, skills and experience) that is required to be disclosed under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("HK Stock Exchange") ("HK Listing Rules") is set out in **Appendix I** to this circular.

Mrs. Kwok Eva Lee ("Retiring Independent Non-executive Director"), being an Independent Non-executive Director of the Company eligible for re-election at the AGM, has made an annual confirmation of independence taking into account the factors referred to in Rule 3.13 of the HK Listing Rules. Mrs. Kwok Eva Lee has served as an Independent Non-executive Director of the Company for more than 9 years. During her tenure on the Board, she has demonstrated her ability to provide independent opinion and constructive views with respect to the Company's matters. Mrs. Kwok Eva Lee has consistently brought in fresh perspectives, skills and knowledge gained from her other directorships and appointments on an ongoing basis. Her wealth of skills, knowledge and experience has enabled her to contribute meaningfully and objectively to the Board as an Independent Non-executive Director and her independence from management has not been considered impaired by her years of service.

Mrs. Kwok Eva Lee has in-depth and diverse international business knowledge and experience from her service on boards of other companies and involvement in businesses across private and non-profit sectors (included listed companies) in different countries which enable her to bring invaluable insight to the Group's international businesses and investments. According to the self-evaluation conducted by the Board of its own performance and the performance of the Board Committees for the year ended 31st December, 2024, the Directors are of the view that the Board has an appropriate balance of competencies, experiences, skills and gender representation as well as sufficient knowledge of the Group.

The Nomination Committee has taken into account the contributions of Mrs. Kwok Eva Lee to the Board and her commitment to her role as Independent Non-executive Director. The Nomination Committee has been satisfied that Mrs. Kwok Eva Lee possesses the required integrity and wealth of skills, knowledge and experience that have enabled her to continue contributing meaningfully and objectively to the Board as an Independent Non-executive Director, and that the independence of the Retiring Independent Non-executive Director from the management has not been impaired by the years of service. Based on the biographical information disclosed to the Company, the Retiring Independent Non-executive Director does not holds seven or more listed company directorships. The Board is satisfied that Mrs. Kwok Eva Lee meets the independence factors set out in Rule 3.13 of the HK Listing Rules and is independent. During her tenure as an Independent Non-executive Director, she has not been involved in the daily management of the Company or financially dependent on the Company which would materially interfere with her exercise of independent judgement. There is no evidence that her tenure has compromised her continued independence.

The Board is of the view that a director's independence should not only be defined by his/her tenure on the Board. The Board assesses a director's independence on a case-by-case basis with reference to the director's business acumen, experience in related industries, professional qualification, international business exposure and the nature of the businesses of the Company. A director who has over time gained in-depth insight into the Company's operations and its markets are well-positioned to offer his/her perspectives and advice for discussions on the Board. Long serving directors can bring valuable contributions to the Company with their comprehensive understanding of the operations of the Company, in particular the infrastructure businesses which typically have a long return of investment period. Taking into account all of the circumstances described in this section, Mrs. Kwok Eva Lee was considered to be independent and nominated to be so appointed accordingly.

The nominations of the Retiring Directors have been made in accordance with the Director Nomination Policy of the Company. Having considered the background and experience of the Retiring Directors (including but not limited to Mrs. Kwok Eva Lee as an Independent Non-executive Director as mentioned above) as set out in **Appendix I** to this circular, the Nomination Committee has been of the view that the Retiring Directors are appropriate to stand for re-election and that their re-appointments would enhance the Board's diversity and performance, and accordingly recommends them for re-elections at the AGM.

The Board, having considered the recommendation of the Nomination Committee, is of the view that the Retiring Directors are able to continue to generate significant contribution to the Company and the Shareholders as a whole. The Board considers that the re-election of the Retiring Directors as Directors is in the best interest of the Company and the Shareholders as a whole. On 19th March, 2025, the Board accepted the nominations by the Nomination Committee and resolved to recommend the Retiring Directors to stand for re-elections by the Shareholders at the AGM. The Retiring Directors abstained from voting at the Board meeting regarding their respective nominations.

Any Shareholder who wishes to nominate a person to stand for election as a Director of the Company at the AGM must lodge with the Company Secretary of the Company at its principal place of business in Hong Kong at 12th Floor, Cheung Kong Center, 2 Queen's Road Central, Hong Kong within the period from Friday, 18th April, 2025 to Thursday, 24th April, 2025, both days inclusive, (i) his/her written nomination of the candidate; (ii) notice in writing signed by such nominated candidate of his/her willingness to be elected as Director; and (iii) the biographical details of such nominated candidate as required under Rule 13.51(2) of the HK Listing Rules for publication by the Company.

3. Proposed General Mandate to Issue New Shares

A general mandate is proposed to be unconditionally given to the Board to issue, allot and dispose of such number of additional Shares not exceeding 10% (instead of 20% as permitted under the HK Listing Rules) of the total number of Shares in issue (excluding treasury shares (as defined in the HK Listing Rules as amended from time to time)) at the date of the passing of the relevant resolution (such total number to be subject to adjustment in the case of any conversion of any or all of the Shares into a larger or smaller number of Shares after the passing of such resolution) and the Shares to be allotted and issued pursuant to this general mandate shall not be at a discount of more than 10% (instead of 20% as permitted under the HK Listing Rules) to the Benchmarked Price (as described in Rule 13.36(5) of the HK Listing Rules) of such Shares until the next annual general meeting. The relevant resolution is set out in Ordinary Resolution No. 5(1) in the Notice of AGM ("Ordinary Resolution No. 5(1)").

The Chairman of the forthcoming AGM will therefore put each of the resolutions to be proposed at the AGM to be voted by way of a poll pursuant to Bye-law 66 of the Company's Bye-laws. If there are any procedural or administrative matters to be dealt with at the AGM, any resolution relating to such matters will also be taken by poll.

5. Further Explanation
